After clicking "Add on Apple Music" and following the onscreen instructions by providing your first name, last name, email address, country, telephone number (including area code) and clicking "Submit," you are officially entered into the pool of eligible entries ("Apple Music Entry"); iii) you may enter by following OneRepublic and saving Dear Santa via Deezer Music service ("Service Provider 3"). After clicking "Save on Deezer" and following the onscreen instructions by providing your first name, last name, email address, country, telephone number (including area code) and clicking "Submit", you are officially entered into the pool of eligible entries ("Deezer Entry"), or iv) you may also enter by clicking "No thanks, I just want to enter the Giveaway" and following the onscreen instructions by providing your first name, last name, email address, country, telephone number (including area code) and clicking "Submit". After clicking "Submit," you are officially entered into the pool of eligible entries ("Online Entry"). If you do not have a Spotify account, you may visit www.spotify.com and create an account for free and sign into your newly created Service Provider 1 account to enter. If you do not have an Apple Music account, you may visit www.apple.com and create an account for free and sign into your newly created Service

Provider 2 account to enter. If you do not have a Deezer account, you may visit www.deezer.com and create an account for free and sign into your newly created Service Provider 3 account to enter. Once properly submitted, the information you supplied via your game play will be considered and referred to herein as "Bonus Entry 5".
