Promoter: UMG Nashville, a division of UMG Recordings, Inc., 222 2nd Ave S, STE 2200, Nashville TN, 37201, U.S.A. ("**Promoter**"). Promoter's decisions are final and binding in all matters relating to the Keith Urban Vegas Giveaway; referred hereafter as the "**Prize Draw**."
